Explanatory note

The course of International Investment and International Investment Agreements is a compulsory course in education of masters in international economy, as it reflects the most important features in transnational investment in an open economy on the contemporary stage of the world economy development and regulation instruments, which are connected with the peculiarities of internationalization and globalization.

The object of the course of International Investment and International Investment Agreements is study of dynamics, determination and impact of transnational investment in the open economy, using various approaches and schools.

The objective of the course is developing of masters' systemic knowledge and skills in the sphere of analysis and governance of transnational investment in economy at the macrolevel taking into consideration features of interactions between IIAs and other areas of small open economy development.

Targets of the course (implementation of requirements to qualification):

- comprehension of theoretical propositions in dynamics of transnational investment in the open economy, using various approaches and schools;
- learning of the structure and content in approaches to government of the foreign direct investment in the open economy;
- learning of the international practice in the governing of the transnational investment parameters in the open economy;
- obtaining skills in identifying of the peculiarities in dynamics and changes of the transnational investment in the open economy and examination of their macroeconomic government, international investment agreements including.

After learning of the course master must:

have known:

- main issues in the international investment area;
- the terms of dynamics, determination and impact of international investment in the open economy;
- interactions between IIAs and other areas of small open economy development;
- peculiarities of different international investment agreements;

be good in:

- identifying the notion of international investment, FDI, its determinants and impacts on the open economy;
- application of key issues and features in International Investment Agreements;

have skills in:

- application of various concepts and definitions in determination of international investment and foreign direct investments;
 - using of the determinants of international investment in economic tendencies' analysis;
 - identifying of the content of international investment policies in home and host countries;
 - application of the main principles in International rules on FDI in economic tendencies' analysis;
 - using of the main issues and features of international investment in International Investment Agreements;
 - identifying of the interaction between IIAs and other areas.

Total academic hours for the course – 102, including total academic hours in auditorium – 48/10, including 28/6 h – lectures, 20/4 h – seminars. Form of control – an exam.

The course of International Investment and International Investment Agreements is based on the knowledge abtained during studies of International Economic Relations on the first level of education.

CONTENT OF TEACHING MATERIALS

Theme 1. International investment: theoretical framework.

International investment: direct and portfolio forms.

Features and peculiarities of foreign direct investment (FDI) and overseas direct investment (ODI). Subjects and objects of FDI relationships, FDI components and classification of FDI. Types of FDI direct investment enterprises (DIE). Reverse, round-tripping, transit FDI and indirect DIE. Special purpose entities.

Features of international portfolio investment. Debt and equity forms. Short-term and long-term of transnational portfolio investment.

Contemporary theories of international investment. Theories of determination of overseas direct investment. Theories of FDI determination. Theories of international investment impacts on countries economic development.

Theme 2. Multinational enterprises and international production: long-term trends and contemporary models.

Transnationalization: definitions and modes. Internalization and externalization. Types of multinational enterprises.

Leading multinational enterprises: role, structure, their activities assessment and trends in development. Transnationality index. Geographical spread index.

Modes and transnational investment strategies of enterprises.

Greenfield investment. Purchases of enterprises overseas. Strategic alliances as modes of international production. Joint ventures and other types of international investment strategies. Cross-border mergers and acquisitions as a type of transnational investment strategy. Types, factors, scales of cross-border mergers and acquisitions in contemporary world economy.

Theme 3. Measurement of international investment and international production.

The role of international investment in the world economy and international production. Indexes of quantity and quality of transnational investment.

Dynamics of foreign direct and overseas direct investment by forms, components, geographical and industrial structure. Tendencies and peculiarities across the home countries and the host countries.

FDI income and ODI income: dynamics and structure.

Transnational portfolio investment dynamics according to the forms and classes of securities. Geographical structure of assets and liabilities.

International investment position. Mirror statistics of transnational investment.

Theme 4. Determinants of international investment.

FDI determinants and ODI determinants. Dependency of the determinants on the industry, strategies of investment, economic development of home and host countries.

Investment climate: composition and methods of evaluation. Transnational investment risks. Ratings of investment climate assessment.

Theme 5. International investment impacts on economic development

International investment impacts on economic development of home countries. Levels and channels of impacts. Direct and indirect ODI-effects.

International investment impacts on economic development of host countries. Levels and channels of impacts. Direct and indirect FDI-effects.

Peculiarities of ODI- and FDI-effects across the countries and industries. Interdependency of transnational investment determinants and impacts.

Theme 6. International investment policy.

ODI-policy: its structure, institutional promotion of ODI. Forms, methods and instruments of ODI governance in home country.

FDI-policy. Investment regimes: definitions, absolute and relative types of the regime. Structure of FDI national regulations measures. Structure of FDI promotion measures.

Theme 7. Sub-national regulation of international investment.

Regulations of transnational investment by regional and international agreements. International investment provisions in economic integration agreements.

Interregional investment agreements. OECD regulatory framework. IMF and World Bank regulation of transnational investment. International investment agreements within WTO.

Theme 8. Main issues and peculiarities of international investment agreements.

Bilateral investment treaties: structure, content, advantages of bilateral regulation. Peculiarities in IIA provisions in international practice of different groups of countries.

Trends in reforms of international system of transnational investment regulation. New types of bilateral investment agreements (India, Brazil, China).

New approaches in international investment regulations in bilateral treaties with investment provisions.
