EXPLANATORY NOTE

Every day households, business and government institutions are faced with many practical issues, the solution of which should be searched in the framework of macroeconomic theory. The discipline "Macroeconomic Analysis and Politics", designed for in-depth training of specialists, involves the presentation of macroeconomic theory, which subsequently turns into consideration of practical significance and a possible application in the field of economic policy.

The purpose of studying the discipline: to provide ownership of the modern knowledge base in the field of macroeconomics and its applied areas, as well as modern analytical approaches and tools.

Tasks of studying a discipline:

- deepening fundamental training in the field of macroeconomic analysis;

- providing knowledge and understanding of modern macroeconomic problems;

- obtaining skills in using alternative theoretical approaches to solving urgent problems of the Belarusian economy.

As a result of studying the discipline, the student must know:

- modern models used in applied macroeconomic research;

- specific macroeconomic problems of the Belarusian economy;

be able to:

- understand modern macroeconomic problems;

- apply macroeconomic theory and its tools to study practical economic problems;

- predict the development of macroeconomic processes and the consequences of macroeconomic policies;

- defend their point of view in discussions on actual problems of macroeconomics.

As a result of studying the discipline "Macroeconomic analysis and policy" the following competencies are formed:

 UC-4. To be able to use fundamental economic knowledge in professional activities;

- APC-2. To be able to analyze the features of macroeconomic policy under various initial conditions for the functioning of the economy, to develop measures of macroeconomic policy.

Interdisciplinary communication. The discipline "Macroeconomic Analysis and Politics" is based on the study of the courses "Macroeconomics", "Higher Mathematics", "Econometrics and Mathematical Methods and Models", etc.

The knowledge gained in studying macroeconomics at an advanced level as a fundamental economic discipline will contribute to a better understanding of the material when studying other economic disciplines as part of the in-depth training of specialists in the fields of education "Economics" and "Management" and serve as a methodological basis when working on a master's thesis.

In accordance with the curriculum of the second stage of higher education (master) in the specialties 1-25 80 01 "Economics", 1-25 80 02 "World economy", 1-25 80 03 "Finance, taxation and credit", 1- 25 80 05 "Accounting, analysis and audit", 1-25 80 09 "Commerce", 1-25 80 10 "Statistics and analysis", 1-26 80 05 "Marketing", 1-26 80 06 "Logistics" 108 hours were dedicated for study of the discipline, of which 48 hours are for full-time education (24 hours of lectures and 24 hours of seminars), 12 hours for part time education (6 hours of lectures and 6 hours of seminars).
