Explanatory note

Objectives and Tasks of teaching and learning

The curriculum "Legal support of food security" is intended for graduate students studying in the specialty 1-24 80 01 Jurisprudence.

The structure of the curriculum and the teaching methodology of the academic discipline take into account the new results of legal research and the latest achievements in the field of pedagogy and information technology, orienting students towards the acquisition of relevant professional competencies.

The purpose studying the discipline "Legal support of food security" is the formation of a comprehensive and comprehensive understanding of theoretical and legal problems of ensuring food security, both at the national and international levels and the ability to apply legal norms to various practical situations in this area.

Tasks studying the academic discipline:

- study of the main theoretical provisions in the field of legal support of food security, as well as the norms of the current legislation governing these relations, its current state and development trends in the Republic of Belarus;

- the formation of skills to correctly assess and apply in practice the norms of current legislation, skills to analyze the content of regulatory legal acts, skills to use reference and scientific literature;

- mastering the method of searching for legal norms that establish the procedure for the implementation of legal relations in the field of ensuring food security and the competent use of their content in solving practical situations, the formation of skills in the preparation of legal documents.

As a result of studying the academic discipline, the master student must: **know:**

- the system and content of the legislation of the Republic of Belarus in the field of food security;

- foundations of international legal regulation of relations in the field of food security;

- Pconcept of legal support of food security;

- the main directions and measures of legal support of food security;

The topics of the discipline "Legal support of food security" are of a complex nature and are based on the knowledge of undergraduates acquired in the study of the disciplines "Civil law", "Agar law", etc.

The total number of hours devoted tothe study of the discipline in accordance with the curriculum is 108 hours, of which classroom - 36 hours. In the daytime form of higher education, it is planned: lectures - 16 hours, seminars - 20 hours. The form of the current certification is credit.

Educational-methodical map of the academic discipline

Methodical recommendations on the organization of independent work of master students in the academic discipline "Legal support of food security "

In mastering the knowledge of the academic discipline, an important stage is the independent work of the master student. It is recommended that a time budget for independent work is on average 2-2.5 hours for a 2-hour classroom lesson.
