# **EXPLANATORY NOTE**

The ultimate goal of the course is to provide students with knowledge about the higher education system of the Republic of Belarus, about the history and structure of the educational establishment «Belarusian State Economic University», familiarization with the content of the educational standard in the chosen specialty.

# The objectives of the course are as follows:

- study of the basics of the organization of higher education in the Republic of Belarus;
- familiarization with the history and structure of the educational establishment «Belarusian State Economic University», the organization of the educational process;
- disclosure of the main directions of education in the chosen specialty, prepare students for studying specific subjects at university level.

The successful completion of the course will produce a number of specific educational outcomes.

The students will obtain the knowledge of:

- fundamentals of the organization of the educational process, research and independent work of students;

The students will master **the skills in**: dealing with materials in the field of higher education; applying methods and techniques of studying at institutions of higher education.

The study of the course in Introduction to the Major will contribute to the development of **Competence** that consist in the ability to implement effective search information technologies in the field of higher education.

The duration of the course is one semester. The course takes the total of 10 academic hours, 10 of which are devoted to in-class activities. In-class activities include 10 academic hours of lecturing.
