HOW TO DO BUSINESS IN A TURBULENT WORLD

Как вести бизнес в турбулентном мире

Entrepreneurs know firsthand what constant shocks and shocks are, and therefore, with experience, many acquire a sufficient margin of safety. A successful business is built on psychologically well-off people and their stable emotional state.

Employees can easily read when the company is in an unstable situation: usually the management increases the distance from ordinary team members, relations in the team deteriorate, and some employees begin to doubt the actions of the manager. As a result, closeness and distrust grow, people find themselves in emotionally unstable states and work worse, and more often make incorrect or unweighted decisions. The matter of this research is how to cope with strong emotions and how to make decisions in colossal instability.

It turns out that taking care of the psychological health of employees is not only about people, but also about business development. 15 % of employees are ready for a lower salary if the company pays a corporate psychologist: many understand that burnout, stress and bad relationships with colleagues are not worth any money.

The feeling of loneliness experienced entrepreneurs and managers in times of crisis, because few people in the team can really understand what they are going through at this time. Employees do not know how difficult it is to make certain decisions, and what is behind the mask of a confident leader. Usually during this period, the manager is expected to have great self-control, they must keep himself in hand and act as a support for the company and employees.

Depending on the climate in the company and the distance between the manager and employees, several behavioral strategies can be used to help cope with the feeling of loneliness. One of the options is to find a community of like-minded people not inside the company, but outside: that is, to unite with other entrepreneurs. Comparing your situation with someone else's experience and being able to share your difficulties with others helps you cope with unpleasant emotions.

So that the distance between the manager and the employees does not increase and distrust does not grow, from time to time it can be reduced and disclosed. For example, a manager can show by a concrete example that there was a situation when he did not know how to solve the problem, but then he still found a good solution. Therefore, on the one hand, he will demonstrate his humanity, and on the other hand, he will give an important message that despite the difficulties, the company will cope with everything.
